4. I understand that I am responsible for LYFL Equipment and Uniforms, and to make sure all my athletes are properly equipped. For football, when players do not cooperate in returning their equipment, I will intervene to assist in getting back the league's property. For cheerleading, when participants do not appear to be actively engaging in the squad prior to the first event of the season, I will withhold their equipment pending compliance. I will return all "spare" equipment to the league and will not stockpile "extras" for my team. Initial: _____
5. In consideration of my being allowed to participate in any way in the **Lassen Youth Football and Cheer League** program, related events and activities, the undersigned acknowledges, appreciates, and agrees that:
 - 1) The risk of injury from the activities involved in these programs is significant, including the potential for permanent disability and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
 - 2) FOR MYSELF, SPOUSE, AND HEIRS I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,
 - 3) I myself, my spouse, and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE THE other participants, the league, the Board of Directors, the volunteers, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct any SYFL event ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property incident to my involvement or participation in this program, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
